



# GUAM DEPARTMENT OF REVENUE AND TAXATION HAS TRANSITIONED TO SBS



On Wednesday, March 20, 2024, the Insurance and Banking Branch of the Guam Department of Revenue and Taxation went live on State Based Systems (SBS), a web based NAIC application that supports state insurance regulation functions.

## CHANGES FOR INDUSTRY effective March 20, 2024:

- **All current and future individuals and all current Business Entities are getting their National Producer Number (NPN) as their license number. All future Business Entities will receive a new system generated license number.**  
Click <https://nopr.com/help/look-up-your-npn> to find your NPN.
- All Guam license and registration applications (original, renewal and reinstatement), appointments and termination of appointments, Class/LOA additions, and address changes must be submitted via NIPR.
- All licensees should use <https://nopr.com/licensing-center/change-contact-info> to view and maintain important contact information.
- All licensees requiring Continuing Education (CE) when renewing their Guam insurance license must be CE Compliant before submitting their renewal application. Use the "Print Education Transcript Button" on the SBS website to review your CE requirements and compliance status.
- All active companies were assigned a new Guam Company Number. Look up your new Company Number using the "Lookup Button" on the SBS website. Your NAIC Company Number (NAIC CoCode) remains the same.

## INSURANCE AGENTS AND OTHER LICENSEES

Use these **free** tools; **NO User Account or login required.**

### License Manager:

- **View License Information:** Verify license information such as National Producer Number (NPN), license status, license expiration date and much more.
- **Print Your License:** License printing is always **FREE** using SBS License Manager!
- **Print Your Education Transcript:** If Continuing Education is required to renew your license use SBS License Manager to print your education transcript.

**Lookup:** A free public lookup tool to view a variety of insurance agent, agency, education course and company information such as National Producer Number (NPN), license status, license expiration date, NAIC CoCode, Course Name, and much more.

**State Launch Page:** Find contact information and links to all SBS tools available for your jurisdiction on the launch page.

## LICENSE ADMINISTRATORS, COMPANIES AND EDUCATION PROVIDERS

**Use SBS for Organizations to collaborate and share information with insurance regulators.**

### **How to Sign Up:**

**Step 1:** Go to [www.statebasedsystems.com](http://www.statebasedsystems.com).

**Step 2:** Select applicable jurisdiction from the jurisdiction dropdown and click "Sign up for SBS for Organizations."

**Step 3:** Follow the prompts to create a user account.

**Step 4:** Login to SBS.

**Step 5:** \*Add entities (licensee's, companies or education providers) using the instructions listed below.

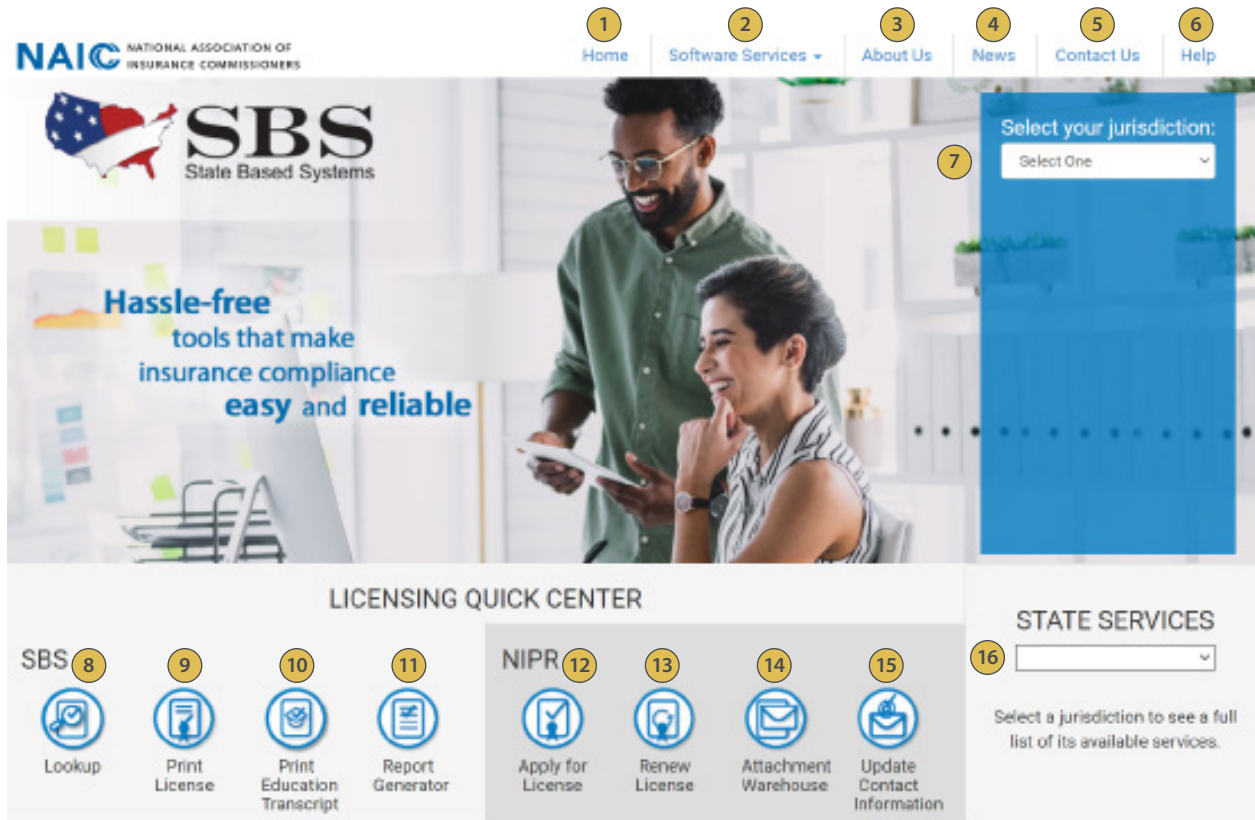
**Step 6:** Simplify your business processes using SBS.

\*License Administrators are required to provide the licensee's last name, National Producer Number (NPN) or license number and the licensee's SSN last 4. A fee of up to \$5.95 is applied per licensee per state.

Company and Education Provider representatives are required to use a unique PIN number associated to each company or education provider. PIN numbers were emailed to each company or education provider on Wednesday 03/20/2024 using their business email address currently on file.

**Report Generator:** Users may create a licensee (individual and/or business entity) mailing list for a nominal fee using a wide variety of criteria.

- 14 **Attachment Warehouse:** Use NIPR.com Attachment Warehouse to upload attachments pertaining to your license application or existing license.
- 15 **Update Contact Information:** Use NIPR.com Contact Change Request to update your contact information include physical addresses, email addresses and phone numbers.
- 16 **State Services:** Select your jurisdiction from the dropdown to view a full list of SBS services.
