New Jersey is live on the new version of SBS!

On Tuesday, March 19, 2019, the New Jersey Department of Banking and Insurance went live on the newest version of State Based Systems (SBS), a web-based application built by the NAIC that supports state insurance regulation functions. This new and improved version of SBS features a suite of tools that offers the insurance industry and consumers quick and convenient access to information they care about.

FREE Licensee Tools

Lookup: A free public lookup tool to view a variety of individual, business entity and company information such as National Producer Number (NPN), license status, license expiration date, NAIC Co Code, FEIN and more.

License Manager: By providing a licensee's last four SSN and NPN or License Number, users can view detailed license information, print the license and update email addresses associated to the license.

External Healthcare Review Participants

All External Healthcare Review processes have moved from SBS Connect to SBS for Organizations. If you are a representative of a health insurance company or Independent Review Organization (IRO) and currently hold a SBS Connect account to manage External Healthcare Review cases, you received an email from the New Jersey Department of Banking and Insurance with information on how to log in and use the SBS for Organizations service.

License Administrator Tools

SBS for Organizations (formerly Online Licensee Services) is an optional subscription service offering convenience to organizational users. Using a single ID and password across all SBS jurisdictions, users can easily and quickly complete the following important license administration functions such as:

- Print licenses
- Update addresses (business entities only)
- View detailed license information
- Receive important notifications

Step 1: Go to www.statebasedsystems.com.

Step 2: Select your jurisdiction and click "Sign up for SBS for Organizations."

Step 3: Create your user account allowing you to access all jurisdictions.

Step 4: Login to SBS.

Step 5: Add licensees to your account as each applicable jurisdiction transitions to SBS.*
