

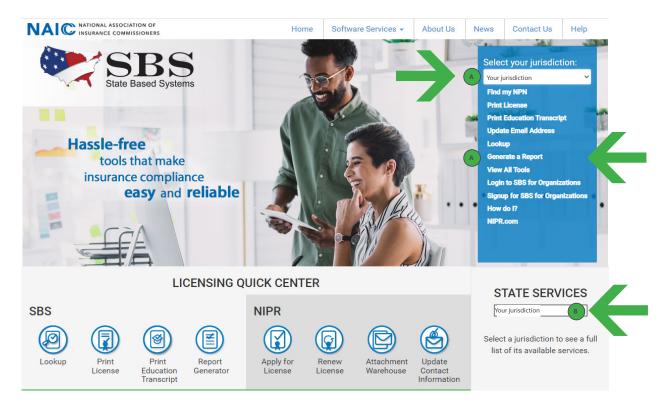
# **HOW DO I:** GENERATE A REPORT OF LICENSEES?

**Report Generator** allows you to request a list of data for a specific jurisdiction using a variety of search criteria. Some of the data included in the report includes: license number, license type, license status, CE compliance, full business address, email address and line of authority.

## Navigate to the Report Generator tool from the SBS website home page

There are two ways to navigate to the Report Generator tool:

- **A. Select Your Jurisdiction:** In the top right, select your jurisdiction. From the options that appear select 'Generate a Report.'
- **B. State Services Launch Page:** In the bottom right hand corner of the screen, select a jurisdiction from the 'State Services' dropdown. Select 'Report Generator' on the State Launch Page.
